## **1.Welcome**

The General body assembled at 2.00 P.M. and it was noticed that there was no quorum i.e, the members present were 56 only, which was not 1/3rd of the total number of members as per the bylaw. Hence, in the absence of the quorum the AGM was adjourned by the President to meet at 2.10. p.m.

The General body re-assembled at 2.10 p.m. and with no further improvement in the quorum, the President Dr.K.Narayanagowda declared the AGM open and thereon, the Secretary, Dr.K.M.Harinikumar extended a warm welcome to the President, Office bearers, EC members and all the members of the Association. He requested the members to participate actively in the meeting and offer their valuable suggestions in the interest of carrying out the Alumni Association activities. He requested the President to chair and conduct the meeting.

## **2.Reverence to the departed members**

Dr. M. A. Narayana Reddy, Executive Committee Member read out the names of members who attained heavenly abode during the period 23-4-2022 to 23-12-2022 and requested the members to observe two minutes silence as a mark of respect to the departed souls.

Sri P.T. Raja; Mr. Chandrashekar, Retd. Professor, Dept. of Entomology; Sri Jagadish Mathad, Sri T.V. Parthasarathy, Former Member, Board of Regents, UAS(B), Dr. Mumtaz Ali Khan, Retd. Professor of Sociology, UAS(B) and Former Minister of Minority Welfare, Hajj and Waqf.; Prof. M.V. Srinivasa Gowda, Professor & University Head (Retd.), Dept. of Agril. Economics, UAS(B); Sri Chikkaravaiah, UAS (B); Sri B.R. Mohan are some of the members who expired during the period.

## **3.To read the notice calling for the 39<sup>th</sup> Annual General Body Meeting of the Alumni Association for the year 2021-22.**

The Secretary read out the meeting notice dated 05<sup>th</sup> December 2022 calling for 39<sup>th</sup> AGB Meeting of the Alumni Association for the information of members.

## **4.Confirmation of the proceedings of the 38<sup>th</sup> Annual General Body meeting for the year 2020-21 held on 23<sup>rd</sup> April, 2022 and the action taken there on.**

The Secretary presented the proceedings of the 38<sup>th</sup> AGM held on 23-4-2022 and action taken there on before the august body and requested to confirm the same.

## **7. To appoint auditors for the year 2022-23 and fix their remuneration**

The Treasurer proposed to continue the same auditors to audit the accounts for the year 2022-23. The house unanimously approved to continue the same auditors for the year 2022-23 and pay their remuneration.

## **8. Budget Proposals for the year 2022-23**

The Treasurer proposed the budget for the financial year 2022-23 and sought for approval. Sri K. Krishnappa suggested the Treasurer to round off the Bank Charges amount to Rs.5,000 instead of fractional amounts. He also suggested to standardize the Heads of Accounts on both Income and Expenditure side.

After discussions Sri G. Narayana Gowda proposed for adoption of budget proposals and seconded by Dr. T. M. Prasad. The house adopted the Budget proposals for the year 2022-23.

Shankare Gowda suggested that to buy the land in the name of the Alumni Association, the proposal should be placed in the Special General Body Meeting for approval and he also suggested that the Alumni Association can approach the State Government also to allot a land for developmental activities related to skill training programmes, field demonstrations etc.

The body decided to leave this subject to the new Executive Committee.

### **11. Presidential speech by Dr. K. Narayanagowda**

In his Presidential remarks Dr. K. Narayanagowda recollected the services rendered by the past Executive Committees under the leadership of Prof. G. K. Veeresh, Dr. N. Sampangi, Dr. K. M. ### **Executive Committee Meetings**
